1. Action taken report of Previous meeting.

- **A, Status of court case:** No fresh date of OREAT case No. 97/24 is received since last hearing on 28-11-25. Rejoinder submitted by new members of KVRWA.

Those who have submitted their tenders earlier within the last date of submission of tender will be informed by phone /SMS/WhatsApp regarding the retendering process and they have to apply fresh if they so desire.
